Please take notice that the Court en banc issued a Resolution dated JUNE 29, 2010, which reads as follows:

"G.R. No. 192088 (Initiatives for Dialogue and Empowerment Through Alternative Legal Services, Inc. [Ideals, Inc.], represented by its Executive Director, Mr. Edgardo Ligon and Freedom From Debt Coalition [FDC], et al. vs. Power Sector Assets and Liabilities Management Corp., represented by its Acting President and Chief Executive Officer Atty. Ma. Luz L. Caminero, et al.) - The Court Resolved to

(a) **NOTE** the Manifestation (In Lieu of Comment) dated June 18, 2010 filed by counsel for private respondent Korea Water Resources Corporation ("KWRC") pursuant to the Order of the Court dated May 24, 2010;

(b) **GRANT** the Motion dated June 2, 2010 filed by the Office of the Government Corporate Counsel (OGCC) for respondent Power Sector Assets and Liabilities Management Corporation (PSALM) for an extension of twenty (20) days from June 4, 2010 or until June 24, 2010 within which to file a comment on the petition;

(c) **GRANT** the Motion dated June 2, 2010 filed by the OGCC for respondent Metropolitan Waterworks and Sewerage System (MWSS) for an extension of fifteen (15) days from June 4, 2010 or until June 19, 2010 within which to file a comment on the petition;

(d) **NOTE** the Comment (on the petition) dated June 23, 2010 filed by counsel for respondent First Gen Northern Energy Corporation (FGNEC) in compliance with the Status Quo Ante Order dated May 24, 2010;

(e) **NOTE** the Comment with Urgent Motion to Lift Status Quo Ante Order dated June 22, 2010 filed by counsel for respondent PSALM in compliance with the Order dated May 24, 2010; and

(f) **DENY** aforesaid Urgent Motion to Lift Status Quo Ante Order for lack of merit." (78)
